

Photographic Competition Rules

Competition Theme

The theme of the competition is ***Living Naturism***. The photographer may interpret this however they wish, but it **must** be compatible with the common understanding of naturism – non-sexual, social nudity.

Who can enter?

The competition is open to any amateur photographer (amateur is defined as anyone whose main income is not derived through photography) over the age of 18 years, living in the UK or overseas.

Anyone connected with Naturists Limited or Naturist Action Group, H&E Naturist and its publisher, and Astbury Formentera; their directors, their management and/or staff, are excluded from this competition.

Deadline

The deadline for the competition is **27th September 2013**. Only entries received on or before that date will be accepted. The result will be announced not later than February 2014.

Entry Fee

The entry fee for the competition shall be £6 for up to three images. Extra images may be entered for an additional fee of £2.50 per image.

The correct entry fee is to be paid in STERLING via the Naturist Action Group's website: naturistactiongroup.org through the DONATE button with the heading 'Photo Comp' and/or a brief message.

All proceeds from the competition, after expenses, shall be given to the Naturist Action Group.

Submissions

Submissions can be made by email: photocompetition1@btinternet.com, with each image not greater than 1.5MB, along with your entry form and model release forms (if necessary). Please put Photo Comp Entry in the subject line.

Submissions will only be accepted if receipt of payment for the correct amount is later confirmed.

Light image manipulation will be allowed.

Apart from the need of identification of multiple image entries (1, 2, 3, etc.), no means of identifying the photographer will be allowed. Images that can be attributed to a photographer will be void.

All images entered into the competition should be the work of the person entering them.

Prizes and Judging

Prizes for the 2013 competition shall be awarded to the winner and runner-up. The winner's prize will be a holiday (accommodation only) for two people, for one week, the runner up a copy of Adobe Photoshop Elements.

The judges have the right to select images as highly commended, which are considered to have considerable merit but not adjudged to be either the winner or runner-up.

Images adjudged as the winner, runner-up and highly commended shall be published in an issue of H&E Naturist, to be determined by the editor.

There is no cash alternative.

For 2013, the judges shall be photographer Laura Pannack (independent), Sam Hawcroft (managing editor, H&E Naturist) and Reg Barlow (Chair, Naturist Action Group).

The judges' decision shall be final.

Copyright

By submitting an image or multiple images to the competition, you confirm that:

- A non-exclusive, irrevocable license is given to the Naturist Action Group, to reproduce, enlarge, publish or exhibit on any media, the image. This may include but is not limited to:
 - News coverage of the competition;
 - Naturist Action Group's website;
 - Exhibitions; and,
 - Publications (e.g. leaflets, reports).

You shall also grant H&E Naturist permission to publish the image (without a fee) in one edition of the magazine as part of the post competition publicity in accordance with the prizes listed above.

Other than for above, copyright shall remain with the photographer. In accordance with the Data Protection Act 1998, Naturists Ltd will continue to hold entrants' contact details and any subsequent commercial opportunities that arise will be forwarded to them.

Legal

Any personal data submitted will be used solely in accordance with current UK data protection legislation. Please see our privacy statement for details of how personal data may be processed.

These rules of entry shall be governed by and interpreted according to English law and the English courts shall have exclusive jurisdiction to deal with any disputes arising in connection with them.
